- I. Mr. Maycock called the meeting to order at 7:10 p.m. with the Pledge of Allegiance to the Flag of the United States of America.

III. Unfinished Business:

- A. TRR/Indian Point Condominiums Rezone from C-1 to C-2-PDD & Subdivision Preliminary Plat: Tabled as TRR is not ready for meeting. Parties involved are reconsidering the need for change.
- **B.** Special Use Permits
 - Recommendation to Board of Trustees for Fee Increase: Tabled for research of costs of each process to suggest specific fee amounts based upon each cost plus small percentage for a full recommendation
 - 2. Special Use Permits Application: Tabled for legal feedback and guidance.
- **C.** Recommendation to Board of Trustees for Clarification of Temporary Use in R-1: The definition of 'temporary' needs to have clear time limits, possibly 3 months or such, but not unlimited time. Need to find out how other villages handle this issue.

- **A. RV Trailer on 1378 Tablerock Circle:** Mr. Howard came to office earlier, had to work during meeting time. Asked for time until end of May.
- **B.** Parking for Convention Center As a problem for resorts, blocking traffic, etc. Original plan was for overflow parking to be on Myrtle Lane, now on Cave Lane. Convention Center occupancy is 100. Tabled for Ron pull P&Z section for 'on street parking'.
- V. Administrator & Code Enforcer Report: Concern for clarity for fences, as to whether a fence is a 'structure', unspecified in actual ordinance for building permitting.
- VI. Items & Comments from Planning & Zoning Commission Members: Mrs. Kurtz asked about a Permits Issued List, published at one time, but not now. Mr. Wehr III expressed that the owner of BIG HOUSE promised the Trustees he would fix bottom of Indian Lane & Tablerock Cir and Heller & Indian Lane. Have Harry write a nice letter.
